



**ENFORCEABLE UNDERTAKING UNDER
THE AUSTRALIAN CONSUMER LAW (WA)**

BETWEEN

UNLEASH SOLAR PTY LIMITED

AND

MR DIONYSIOS PERDIKOYIANNIS

AND

COMMISSIONER FOR CONSUMER PROTECTION

RECITALS

The parties **ACKNOWLEDGE:**

- A. These undertakings are enforceable under s218 of the Australian Consumer Law (WA).
- B. The Commissioner for Consumer Protection expressly reserves her rights with respect to any subsequent action.
- C. The rights of consumers are otherwise unaffected by this undertaking.
- D. These undertakings are not confidential, and may be made available to Western Australian consumers.

UNDERTAKINGS

1. Unleash Solar Pty Limited shall do all things necessary to **INSTALL** the photovoltaic systems, either as contracted or otherwise agreed between Unleash Solar Pty Limited and its current Western Australian customer(s), in relation to the following Western Australian customers:

- 1.1 the Perth metropolitan customers described in Annexure 1, on or before **23 December 2011**; and
 - 1.2 the non-metropolitan customers described in Annexure 1, on or before **20 January 2012**; and
 - 1.3 All other customers by **29 February 2012**.
2. Unleash Solar Pty Limited shall **REFUND** all monies to those Western Australian customers described in Annexure 2 (being those who have requested refunds), and those customers who have elected to receive a refund rather than effect an installation after the date of this undertaking, in accordance with the date described in paragraph 1.1. This paragraph shall not operate so as to prevent a Western Australian customer from electing to have a system installed rather than being refunded, in which case paragraph 1.3 applies.
 3. Unleash Solar Pty Limited shall cause to be displayed on its home page website www.unleashsolar.com.au a reasonably prominent message, in font of reasonably prominent size, to the effect that new Western Australian customers are not presently able to be supplied.
 4. Mr Dionysios Perdikoyiannis shall do all things necessary to cause Unleash Solar Pty Limited to comply with these undertakings.



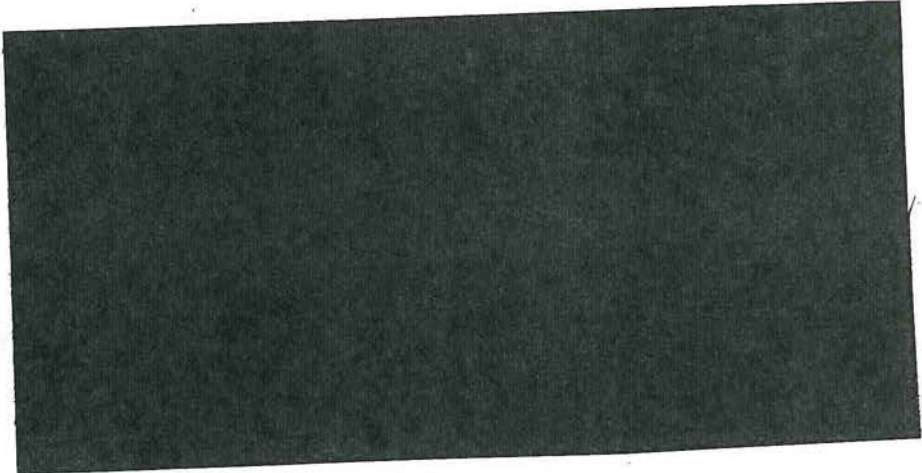
